These experiences can also occur in the process of seeking treatment including access to culturally responsive services. It is the aim of these presentations to provide community members, social workers, counselors, clinicians, and administrators with enhanced awareness, knowledge, and skills toward the elimination of health inequities and improved patient experience of care.
